TERMS AND CONDITIONS:

1. Account and Payment Status

- All tuition and/or fees must be paid in full and when due in accordance CSPA's Rate Brochure and published payment policies, and/or any payment plan agreed to between you and CSPA.
- By participating in and accepting CSPA's services, activities and/or classes, you accept and acknowledge responsibility for all tuition and fees related to such services and classes set forth in CSPA's Rate Brochure. By signing this Registration Contract, you warrant and acknowledge that you have carefully read CSPA's Rate Brochure and all published and/or disseminated studio policies and fully and unconditionally agree to the terms and conditions set forth therein.
- If any payment owed with respect to your account is more than 30 days past due, your account shall be considered delinquent. Registration / enrollment may be rescinded at the sole election of CSPA if your account is delinquent. A late fee of \$15 may be charged to any delinquent amounts owed on your account. Any election by CSPA not to rescind your registration / enrollment or charge a late fee in the event of delinquency shall not be a waiver of CSPA's right thereafter to impose such remedies for subsequent delinquencies.

2. Release and Hold Harmless Agreement

In consideration of CSPA permitting the student / participant to register and/or enroll in CSPA's services, activities and/or classes, the undersigned parties hereby forever and unconditionally release, remise, discharge, indemnify, and hold harmless CSPA and its principals, owners, managers, members, officers, directors, faculty, instructors, agents, servants, employees, predecessors in interest, successors in interest, or assigns, from any claim, demand, action, cause of action, debt, obligation, or liability, whether accrued or unaccrued, for any loss of property or bodily or personal injury in any way arising out of or related to the student / participant's participation in any of CSPA's services, activities and/or classes.

Without limiting the generality and applicability of the foregoing paragraph, the undersigned parties hereby specifically accept, agree, and acknowledge that certain risks of harm are or may be inherent in the services, activities and/or classes contemplated by this Registration Contract, and CSPA cannot control all such inherent risks. In this regard, the undersigned parties accept, agree, and acknowledge that dance and gymnastic training and activities can place stress on the body and carry with them a risk of physical injury that CSPA cannot eliminate. The undersigned parties further specifically accept, agree, and acknowledge that a COVID-19 pandemic exists worldwide as of the execution date of this Registration Contract, and a risk of contracting and/or being exposed to the COVID-19 virus may be inherent in the services, activities and/or classes contemplated by this Registration Contract, and CSPA cannot control all such inherent risks.

3. Media and Publication
